Contemporary playwright Katori Hall, a Memphis, Tennessee, native, has been dominating the American theatre scene with notable plays that center on the Black experience. This panel will consider Hall's most groundbreaking play thus far, *Pussy* Valley, and the subsequent television series adaptation P-Valley. With P-Valley, Hall effectively documents Black women's cross-generational, intersectional oppression within the setting of what was formerly a small-town Mississippi Blues juke joint, now converted into a strip club called the Pynk. Hall's drama/teleplay critically examines the cultural narratives, practices, and means of reproduction that oppress the club's owners, workers, and patrons dating back to the era and setting in which the Blues was born. Even further, P-Valley's deep South setting effectively evokes American slavery, which still thrives culturally as human sex trafficking, political corruption, and misogyny take center stage. The papers in this panel collectively examine how P-Valley is inspired by a dramaturgy of repetition, resistance, and resilience and how Hall revolutionizes contemporary theatre and television by comingling Southern Black life, Black/queer/non-binary characters, and traditions of haint and hoodoo culture.

Accountants' Responsibility

Our responsibility is to conduct the review engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the American Institute of Certified Public Accountants. Those standards require us to perform procedures to obtain limited assurance as a basis for reporting whether we are aware of any material modifications that should be made to the financial statements for them to be in accordance with the cash basis of accounting. We believe that the results of our procedures provide a reasonable basis for our conclusion.

Accountants' Conclusion

Based on our reviews, we are not aware of any material modifications that should be made to the accompanying financial statements in order for them to be in accordance with the cash basis of accounting.

Basis of Accounting

We draw attention to Note A of the financial statements, which describes the basis of accounting. The financial statements are prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our conclusion is not modified with respect to this matter.

Note A – Nature of Activities and Significant Accounting Policies

Nature of Activities

Southern States Communication Association (the Association) is a nonprofit organization that promotes the study, criticism, research, teaching, and application of the artistic, humanistic, and scientific principles of communication. It exists for educational, scientific, and literary purposes only. Southern States Communication Association began activities May 2, 1930.

Cash Basis of Accounting

The Association's policy is to prepare its financial statements on the cash basis of accounting; consequently, revenues are recognized when received rather than when promised or earned, and expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to present financial position and activities in conformity with generally accepted accounting principles.

Cash and Cash Equivalents

The Association considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

Income Taxes

The Association is a not-for-profit organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation.

The Association's Forms 990, Return of Organization Exempt from Income Tax, for the years ended July 31, 2020, 2021, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

Date of Management's Review

Management has evaluated subsequent events through April 6, 2023, the date on which the financial statements were available to be used.

Note B – Concentrations of Credit Risk

The Association maintains cash balances at two financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. The Association had no uninsured cash balances as of July 31, 2022 and 2021.

SSCA 2020-2025 Strategic Plan

Background

The SSCA constitution states that the officers shall meet for the purpose of strategic planning, and that no more than five years shall elapse between such meetings. According to the SSCA constitution, members required to attend strategic planning sessions include current members of the SSCA Administrative Committee and those invited by the President.

Previous SSCA strategic planning meetings were: 2003 (Memphis), 2004 (Tallahassee), 2006 (Ellijay, Georgia), 2010 (Orlando, FL), 2016 (Charleston, SC), and 2021 (remotely).

Process

The Administrative Committee met several times over the 2021-2022 academic year to discuss plans for the next strategic plan. Unfortunately, due to the COVID-19 crisis and the untimely death of our president in 2019 (Dr. Shawn Long), this process has been delayed. The committee conducted all meetings online since an in-person gathering was not a possibility.

The committee included:

- Andrew Pyle, Clemson University, Strategic Communication Director
- Kevin Bryant, Clemson University, SSCA Executive Administrator

In preparation for the current strategic plan discussion, all committee members studied the two previous strategic plans, searching for ideas that might still be relevant to the organization today. We also discussed changes to the discipline, the organization, higher education more broadly, and social shifts that might guide our plan moving forward.

Accountability in the Strategic Planning Process

We acknowledge all the obstacles that the organization has recently faced and, focusing on the strengths of the organization, have devised a plan to strengthen SSCA over the next few years.

In reviewing previous SSCA strategic plans, we discovered that there were many ideas that were still relevant to the organization today. We recognize the difficulty of overseeing a five-year plan when the organization is led by volunteers who cycle out of positions. Consequently, one part of this current plan is to implement a completion plan.

The plan will include:

- Creating a task force to continue to develop ideas between strategic planning years, to collect ideas from members, and to assist the officers with implementation of the plan
- Reporting strategic plan accomplishments at the mid-year and annual business meetings
 - o Kevin Bryant will do this for the 2023 convention
- Continuing to suggest changes to the strategic planning process
- Scheduling a session on strategic planning at the annual conference
- Decide on a committee/leadership structure for this task force

Looking Forward: Showing Resilience in the Association

The theme for the 2022 conference, "Resilience through Resistance," also reflects the continued strength of our organization. Given all the obstacles that SSCA has faced in the last three years, it is noteworthy that we have emerged even stronger. We have shown resilience by working together. Looking beyond the conference and into the next few years, the Administrative Committee has drafted our newest strategic plan to keep our organization resilient. Pulling from the best ideas of our predecessors and recognizing needs that we feel haven't yet been met, we created a plan that includes the six issues listed below.

1. Making Diversity and Equity Initiatives a Priority

We pledge to continue to make SSCA a welcoming and inclusive organization. In 2020, we oversaw the creation of the Diversity, Equity, and Inclusion committee and we introduced constitutional changes at the 2022 conference to make the DEI committee chair a sitting member of the Administrative Committee. In order to make these leadership positions more approachable, we will pursue the following actions:

- Incorporate a designated spotlight panel into the annual conference that examines the conference location, addressing the politics of place
- Ann Burnette created a spotlight panel for Florida 2023
- Develop resources for SSCA leadership, sharing them through panels and a web site section
- Hold scholar office hours at the spring conference, including scholars who are recruited to discuss leadership
- This should start at the 2024 conference in Frisco, TX.
- Develop short courses focused on professional development on topics such as
 - Chairing a department
 - Publishing
 - Leadership options in the discipline
 - Advising graduate students
- Recruiting in different areas to diversify membership
 - Also later in list—recruit at HBCUs, community colleges—invite faculty/students who haven't been involved
- Make DEI initiatives a part of each of the following strategic goals

2. Provide Additional Mentoring and Leadership Opportunities for all SSCA members

We see one of the strengths of SSCA as proving important leadership opportunities for our members. With a diverse and broad pool of leaders, the organization and the discipline more broadly are stronger. Members are also able to take that leadership experience back to their home institutions. In order to make these leadership positions more approachable, we will pursue the following actions:

- Provide regular conference panels on leadership and mentoring topics
- Develop resources for SSCA leadership, sharing them through panels and a web site section
- Undertake an update of the Officers' Manual
- Wendy Atkins-Sayre completed this during the 2022-2023 convention cycle. An updated officers manual is available under the "Members" tab of our website.
- Develop short courses exploring leadership topics
- Hold scholar office hours at the spring conference, including scholars who are recruited to discuss leadership
- This should start at the 2024 conference in Frisco.

- Work with the DEI Committee to develop more ways to provide mentorships for all, but especially underrepresented groups
- Inform members how they can become a part of leadership
- Implement a formal mentoring process
- This could include the creation of a Student Caucus/Interest Group to foster mentoring opportunities from and for undergraduate/graduate students
- 3. Providing Additional Professional Development Opportunities for all SSCA Members

 Not only do we want to provide more leadership opportunities for a wider group of
 people and provide guidance for those individuals, but we also want to give all SSCA
 members—at every type of institution, at every level of education and higher education
 position—resources for meeting their professional goals. Consequently, we will work to
 provide additional opportunities through the following actions:
 - Continue scheduling annual panels on professional development
 - Develop web resources for members that address:
 - Advice for tenure and promotion
 - Advice on publishing
 - Job listings
 - Teaching materials
 - o Programmatic assessment info
 - Information about chairing a department
 - Consider options for planning online mini conferences committed to professional development (also serving as another revenue generator)
 - Develop short courses focused on professional development on topics such as
 - Chairing a department
 - Publishing
 - Leadership options in the discipline
 - Advising graduate students
 - Plan a panel for the Undergraduate Honors Conference on selecting and applying to graduate programs
 - Continue to develop offerings for a graduate school open house in order to provide more opportunities for undergraduate and MA students to connect to regional programs
 - Increased the number of UHC sponsors and Grad Fair booths from 9 to 15 for 2023 convention
 - Increased the hours of operation of the Grad Fair from 1.5 to 3 hours for the 2023 convention

4. Improving Communication

Although we have made improvements to our communication channels (web site, emails, newsletters) in recent years, we recognize that there is additional, important work to do to communicate with our members more effectively. In order to improve those channels, we will commit to:

- Continue working on the SSCA web site, exploring the best options for host sites and web site design/layout. In particular, we want to improve the experience for membership renewal and conference registration.
- New website editor coming
- Improve our use of social media, regularly using those options to communicate with members and others
- Strat Comm Director will work with Resource & Member Development committee on a social media campaign
- Send quarterly emails with consistent content, including
 - Planning report
 - Newsletter
 - Award spotlight
- Undertake an update to the officers' manual, including information for program planners
- Wendy Atkins-Sayre completed this during the 2022-2023 convention cycle. An updated officers manual is available under the "Members" tab of our website.
- Produce the SSCA podcast more regularly
- Continue work on creating a schedule of pod release dates
- Bring in local hosts at conference sites in order to improve communication about those locations

5. Increasing Revenue for the Association

Although the organization is financially strong, we know that it is imperative that the leadership continue to find new ways to bring in revenue in order to keep membership and conference rates as low as possible. Consequently, we will pursue the following goals:

- Explore more options for revenue streams more broadly, especially searching for options that might bring in revenue throughout the year, such as web advertisements and other member services.
- Explore the option of eliminating the printed program without sacrificing the income that program advertisements bring
- Plan for ways to fundraise for named awards and receptions so that those expenses do not require as much funding from the SSCA budget
- New Strat Comm Director
- Approved by the ED John Haas during the 2022-2023 convention cycle

6. Study the Future of our Conference

After experiencing the benefits of online conferences, we will consider possibilities for enhancing our spring in-person conference.

- Continue to consider the future of our spring conference, given online and hybrid options that have emerged in recent years
- Survey members to better understand their needs and desires in relation to the spring conference
- Reconsider the planning process, making sure that we have the best online platform, planner training, and model for scheduling panels.
- Ann Burnette hosted two planner sessions at the 2022 Greenville conference and two additional planner sessions with XCD – our submission platform
- Explore best practices in risk communication, making a leadership plan that will help guide the organization through future challenges
- Establish African American Comm Division

7. Misc Ideas from Task Force Meeting

- UHC recruitment Improve communication and outreach with HBCU and community colleges so they know about options for involvement
- Develop small scholarships for these students to come and observe/participate based on the NCA model
- Get more people involved who haven't historically been involved
- Implement a "comments section" spot at conference registration—someone who can listen and take notes

5.7 - Editor's Report - Southern Communication Journal Benjamin R. Bates


The Southern Communication Journal published all issues on time for the volume 87 (2022) year. Issues for volume 88 are all on time.

In volume 87, we used 100% of our page space, indicating robust submissions recommended by two or more reviewers for publication and approved by the editor.


Beginning with the 2023 year, we will no longer be using page counts to calculate our journal space. In conversation with Taylor & Francis, we have moved to an unlimited page space model. The minimum unit of measurement to meet the new T&F page budgeting is that SCJ should produce 26 "core" articles and 12 "non-core" articles per year. "Core" articles include research articles and review articles, which are currently published by SCJ, but also allows the opportunity for the next editor to consider case reports, data notes, systematic reviews, and other forms that are not popular in SCJ but are published by other communication outlets. Although our peer journal group - Communication Quarterly, Communication Studies, and Western Journal of Communication – do not publish these items, it is important to note that we may be losing excellent data notes and brief reports to WSCA and ECA because they publish Communication Reports, Communication Research Reports, and Qualitative Research Reports in Communication. "Non-core" articles include front matter and back matter, but also book reviews, editorials, letters, expressions of concern, corrections, and similar items. We already are credited with 5 "non-core" articles by virtue of our front matter, and an additional non-core article for our reviewer list at the end of the year. The next editor may wish to consider using the space for editorials, but also inviting some reviewers to write "letters to the editor" that could expand on review notes for eventually published articles.

SCJ received 233 manuscripts, 130 of which were original submissions. This is about 100 total manuscripts higher than the previous year.

For the period January 1, 2022 to December 31, 2022, final disposition was 157 rejections after desk or peer review and 99 acceptance after peer review. This represents an acceptance rate of ~39% for 2022 (first chart). This is lower than the 44% acceptance rate for volume 86. This percentage is higher than T&F requests, but reflects (1) that my team and I are committed to using our page space as fully as possible and (2) we are committed to development of manuscripts by using peer review as a strengthening process in addition to using peer review as a gatekeeping process.




Preliminary numbers for 2023 show that we will process fewer manuscripts in the final year of my term. This is because we have some backlog from the 2022 calendar year and because we are in the wind-down phase of my editorship. Nevertheless, in 2023, we will be maintaining our decisions to publish from the perspective of peer strengthening. Our preliminary 2023 decisioning shows that our reviewers continue to coach authors through the writing. If the current trend holds, volume 88 will have an acceptance rate between 35 and 40%.



SCJ continues to maintain is international footprint in two ways. Although our editorial board consists mainly of scholars established in the American South, we have actively recruited and actively have reviewed for us scholars from the Global South as well. I encourage the next editor to continue to maintain an internationalized editorial board. Second, we continue to see significant international interest in publishing in our journal. We have received submissions from all inhabited contents and from all world regions. Moreover, although most of our authors (both at submission and at eventual publication) are based in the United States, in volume 87 we

published scholars from North America, South America, Europe, Asia, North Africa and the Middle East, and Oceania.



Finally, reviewers are becoming more difficult to recruit and are taking longer with their reviews. In conversations with the other regional editors, SCJ is not alone in this. Over the course of the pandemic, the pandemic and the recognition of general exploitative workloads by universities and colleges, our colleagues are becoming more reluctant to take on voluntary tasks and those who do agree are struggling to fit reviews in. Although our average time from submission to decision is a respectable 49 days, it is incumbent on our colleges and universities to find ways to recognize and reward this form of disciplinary service to enable more of our colleagues to participate in reviewing.

5.8 - NCA Legislative Assembly Report

SSCA Legislative Assembly Representatives:

Patrick Bennett - Midlands Technical College April Chatham-Carpenter - University of Arkansas at Little Rock Eletra Gilchrist-Petty - University of Alabama in Huntsville

The following is our report from the annual National Communication Association Legislative Assembly Meeting held on November 16 & 19, 2022, in New Orleans, LA.

A. NCA Finances

- 1. An independent auditor's report was presented, along with the proposed 2023 budget
 - a. Our operating expenses exceeds our revenues and has done so for the past several years (by about \$700,000 annually)
 - b. Operating budget doesn't include our investment portfolio
 - c. 74% of revenue comes from investments
- 2. NCA has lost money on the convention for the last several years due to increase in costs associated with the convention.
- 3. NCA as an organization expects to break even in 2022 but suffered some investment loss due to stock market changes.
- 4. Publication contract will run out in a few years, changing the source of input potentially.
- 5. Trying to reinstate their charitable status in states because there may be donors interested
- 6. Carriage House property is a possible way of generating revenue if rent it out 1500 square feet, but needs renovations

B. Membership Survey

- 1. NCA distributed a membership survey for the first time regarding the organization a consulting firm designed the survey and analyzed survey results. They received 1290 responses (23% response rate), with a slight overrepresentation of regular vs. student members.
- 2. There was a mixture of positive and negative comments. Positive comments focused on the convention, communication from the NCA, and the opportunity to build community and networking. Negative comments were centered around the convention experience, the culture of NCA, and the cost of the convention.
- 3. Most respondents indicated they were likely to renew membership next year.
- 4. Overall satisfaction ratings 57% were satisfied or very satisfied with NCA; about ½ are neither satisfied nor dissatisfied
 - a. Dissatisfied reasons were the convention (accessibility, health, travel, location), culture (political nature & toxic), & cost (too high)
 - b. Satisfied reasons were the convention (sharing of resources & research), communicating mechanisms of NCA, community/networking, &

connecting to the discipline

5. Concerns were raised about the survey, such as collapsing the categories, and some important things being excluded from the survey, such as (dis)ability.

C. Strategic Plan

- 1. The NCA approved an amended five-year strategic plan after a long discussion on language centered around balancing the budget and reducing deficits.
 - a. Vision: Transforming lives through communication
 - b. Mission: Advancing scholarship, teaching, and practice to foster a better world
 - c. Four goals & objectives
 - i. Create conditions to support & empower members
 - ii. Promote communicator's value
 - iii. Embrace & enact inclusion, diversity, equity, and access
 - iv. Cultivate a thriving and responsive organization
 - d. Five strategic priorities
 - i. Cultivate communication research
 - ii. Enhance communication teaching & learning
 - iii. Disseminate knowledge about communication
 - iv. Facilitate professional development for communication scholars & educators
 - v. Manage the association effectively & efficiently
- 2. Along with an approval of the strategic plan, NCA also approved the IDEA (inclusion, diversity, equity, & access) strategic plan, in light of recent problematic policies and the distinguished scholars controversy.
- C. The Communication and Anxiety Apprehension was approved as a new Interest Group.

6.1 - Committee on Committees Report - Tina M. Harris

- a. Thank to you everyone who has tirelessly volunteered their services and time to various leadership positions. Please continue to volunteer and encourage others to be engaged in SSCA.
- b. We are in talks about how to best deal with membership concerns regarding states in the SEC that pass laws and policies that are in direct opposition to academic freedom, human liberties, diversity, and more. As a 501(c)(3), we cannot plan or promote a protest; however, members as individuals can do so and not on hotel property.

The following changes were suggested and implemented for the SSCA Constitution. Special thanks are extended to Kevin Bryant and Nakia Welch for their thorough attention to detail.

General:

- The constitution was edited to correct grammatical issues and structural alignment (Roman numerals, Section numbers, spacing, indentation, etc.).
- Clarifying language was suggested and implemented in various sections.
- Nakia Welch proposed some larger questions that need to be discussed. Those questions
 are preserved in the document "SSCA Constitution Proposed Revisions Implemented." I
 have listed the questions below.

Article IV: Officers of the Association

Section 4 – Duties of Officers; Executive Director (#2)

- Currently states: The Executive Director shall notify the National Communication
 Association Executive Offices of the names and addresses of the newly elected High
 School, College/University, and Community/Two Year College Representatives to
 Legislative Assembly as soon as possible after the election results have been announced.
- Question/Suggestion for discussion: This needs to just state LA Reps b/c what if we don't
 have a HS rep? This issue was addressed a year or two ago, I believe, where the wording
 was changed to basically state when possible (for HS)...I think that's what I remember from
 a meeting.

Section 5: Vacancies (#3)

- In the event of an Executive Director vacancy, the Executive Council shall put forward a replacement for ratification by the association membership.
- Replace with '...for ratification...' (DONE) This better described the process and it doesn't
 make it sound like they MUST be ratified (accepted/approved) b/c what happens if the
 association membership doesn't ratify that person? Not likely to happen, but it could
 become a constitutional issue as the argument would be made that once a name if put
 forward, they are guaranteed that position...that the association has no choice but to ratify
 them.

Article V: Executive Council

Section 1-Membership.

- Numbered list changed to bullet points.
- Question regarding numbering: All members, regardless of which Arabic number they are specified in here, are members...so why the numerical separation and numbering? What makes the chairs #2 (over) the immediate past members #3?

Section 5 - Emergency Procedures.

- As Currently Written: In case of an emergency that would make it either impossible or
 impractical for the president to convene the Executive Council, the President may empower
 an Emergency Council consisting of the President, the Immediate Past President, the 1st
 Vice President, the 2nd Vice President, and the Executive Director to act for the Executive
 Council. The President may consult each member to determine what action is to be taken
 on behalf of the Executive Council. Items not requiring an immediate decision are to be
 decided by polling the entire Executive Council.
- Question regarding this policy: It seems that this is a response to the Covid situation we
 found ourselves in during 2021. Perhaps crafting an additional statement that indicates
 meetings may be held remotely, in cases of emergency, would be beneficial. For example,
 it's better to be allowed for the EC to meet via Zoom (or whatever new remote meeting
 technology exists in the future) than to not meet at all leaving meeting content to be held
 only by the five-member emergency council. There's no reason the entire EC can't meet in
 cases of emergency (even if remote/Zoom-style).

Section 6 - Quorum

- **As Currently Written:** Those members of the Executive Council present at a regularly scheduled and announced meeting of the Executive Council shall constitute a quorum.
- **Clarification Question:** This could be interpreted as requiring all members present...should there be a set minimum number or % of EC members present?

Article VII: Nominations, Elections, and Appointments

Section 4. Elected Officers (#2)

- **As currently written:** Officers to be elected every three years are the representative to the NCA Nominating Committee.
- Clarification Question: In Art. VII, Sec. 1, #1, it states one year service...but here it states 3 years. Which one is correct?

Section 6. Appointed Officers.

- As Currently Written: The Executive Director and Journal Editor shall be appointed one year prior to taking office.
- Clarification Question: Does this mean that the ED is appointed one year prior to taking office? Is this saying they are elected the year prior? Is it saying they are appointed by the Exec Council the year prior? The wording makes it seem like the appointment occurs a full year prior, THEN they take office. How can we word this in clearer way?

- **Suggestion:** (Related to previous comment) -- I believe it should specify and be included in the Chair's responsibilities to run the program/business meeting

Piyawan Charoensap-Kelly, Chair

Ratification: The Committee forwards Dr. Rebekah Fox as the committee recommendation for the next editor for *Southern Communication Journal (SCJ)*.

Rebekah Fox (Ph.D., Purdue University) is a Professor of Communication Studies at Texas State University. She has received multiple research awards including the SSCA's Janice Hocker Rushing Early Career Award, the James Madison Prize for First Amendment Studies from the SSCA Freedom of Speech Division, top paper awards, and Texas State's Presidential Award of Distinction in Scholarly/ Creative Activities. She is a current member of SSCA in good standing.

Dr. Fox's research falls into three categories; 1) organizational rhetoric, with a focus on power, control and learning in organizations, 2) health communication with a focus on the U.S. nursing shortage and nursing work, and 3) the rhetoric of social movements, with foci in environmental rhetoric, freedom of expression, and political communication. Her works appears in outlets as varied as *Health Communication*, the *Journal of Contemporary Rhetoric, Environmental Communication, First Amendment Studies, International Journal of Wildland Fire*, American *Journal of Nursing*, and *Nursing and Health Sciences*. She is an applied scholar who values research that both advances theoretical understandings and offers practical applications.

Dr. Fox served as the editor of *Communication Law Review* where she learned the importance of a diverse and dedicated editorial board, and how important it is to maintain and grow this group, including mentoring new reviewers. Additionally, she served as the editor for the conference proceedings for three *International Association of Wildland Fire* Conferences, which provided her the opportunity to work with authors whose first language was not English. She worked to polish arguments, format scientific findings, and confirm translation accuracy. She is also proficient in helping others build arguments that justify their research design and their overall contributions. She believes this skillset will be helpful in her role as editor of *SCJ*.

She currently serves as a manuscript reviewer for *Management Communication Quarterly*, *Fire*, *Communication Law Review*, *Texas Speech Communication Journal*, and *Communication Teacher*. She also consistently reviews submissions for the SSCA annual convention for the Freedom of Speech Division, Applied Communication Division, and Instructional Communication Division.

Dr. Fox values multiple methods and uses multiple methods in her own work. She recognizes the importance of understanding when to use different methods and how they match up with research questions and specific research designs. She is also committed to the priorities of ethical, timely, and effective peer review that reflect the standards of *SCJ*.
