While protesting gun laws on the floor of the Tennessee legislature, state Representatives Justin Jones (D) and Justin Pearson (D) drew the ire of their Republican colleagues. In the immediate aftermath, Jones and Pearson were removed from their committee assignments and formally expelled from the state legislature. Although they have since been reinstated, the case nevertheless typifies recent threats to free speech in the US where citizens who belong to a community or organization are forced into a state of unbelonging. In this mixed-methods paper, the author, a published ethnographer of religious communication who also identifies as an evangelical Protestant, combines findings from their fieldwork about biblical literalism and anti-intellectualism in American evangelical culture with autoethnographic moments that critically illumine key insights. Observations of Sunday schools, Easter pageants, children's programs, sermons, Bible study curricula, and other artifacts reveal a culture for whom the

Bible is dominant symbol and mediator of all meaning. Findings are combined with an autoethnographic account of the author's experience across four decades of "how the Bible works" in evangelical culture. The paper recounts a series of epiphanies through which the author struggled with and moved past pre-critical naivete, achieving a new balance and integration, consistent with their core religious identity, between reasoned biblical faith and critical biblical scholarship. Alongside the fieldwork findings, this autoethnographic research gives added insight into the cultural work of the Bible as sacred totem of American evangelicalism and the cultural power of "Bible-believer" at the core of evangelical identity.

This year's Southern Colloquium on Rhetoric round table will commemorate the 70<sup>th</sup> anniversary of the U.S. Supreme Court's **Brown v. Board of Education** decision [347 U.S. 483 (1954)] by considering the text of the decision in light of recent efforts to suppress voter registration, limit the right to protest, impose government dictates and gag orders on the teaching of slavery, race, American history, and "controversial" or "divisive" issues, and ban books that offer

an unsanitized view of America's long struggle with racism. Discussants will prepare a five-minute take on the **Brown** decision from a 2024 perspective, focusing on questions such as, What are the core constitutional values articulated in **Brown**, and what is their status today? Given the Roberts Court's willingness to gut the Voting Rights Act, is **Brown** in jeopardy? Does the rhetoric of "Ed Scare" (the recent legislative attacks noted above) contradict or undermine the rhetorical efforts of the Court in **Brown**? Are our universities' attempts to ensure diversity, equity, and inclusion in keeping with the spirit of **Brown** and are they threatened as well? These and other key points will inform our discussion as our colleague Professor Melody Lehn then opens the floor and moderates what we believe will be a lively conversation and debate.
